### Submission of data

We will send you a P11D Upload Template spreadsheet which is split into each section of a P11D and details all the information that we require to help finalise your end of year reporting. This will be sent in response to your reply.

Please remember to advise us of any expenses and benefits provided to members of the Director's or employee's family or household (if relevant).

If you have separate PAYE companies, we ask for all information to be on separate spreadsheets to ensure all data is correct when sent over.

Some of the fields within the spreadsheet are pre-populated with drop down values to further simplify the completion. Data cannot be accepted in any other format and may be rejected if the template has been manipulated.

Data has been added to the spreadsheet to help support you when completing your information. Please be aware that this does not include any updates from HMRC that have not yet been updated on the website. Therefore, please double check the information via the links provided to make sure that these have been updated.

### Delivery Method of Your P11D Output

The P11D Upload template you will be sent has one mandatory option of choosing how you would like your P11Ds to be sent which is via the ESS/Engage app. If you already use our ESS/Engage app then P11Ds will show as normal in the employee's documents by 4th July 2025. If you do not use this, then we can simply turn this on for you at no additional charge. If you would like more information on this, please let us know in your reply.

A Paper P11D option is no longer available in the Tax Year End Services. Please be aware that we can only report the P11Ds to HMRC via electronic submission.
